Dear Mr. Sweat:

We are responding to your request for verification of an Aquatic Resource delineation for the Wasatch County School District Heber High School site. The approximately 66.56-acre project site is located north of UT-113 and west of 600 West, Latitude 40.51181°, Longitude -111.42729°, Heber City, Wasatch County, Utah (enclosure 1).

Based on available information, we concur with your aquatic resources delineation for the site, which consists of approximately 1.21 acres of emergent marsh wetland, 0.19 acres of wet meadow wetland, and 2,205 linear feet (0.39 acres) of perennial channel, as depicted on the enclosed "Figure A1: Proposed Heber High School Site Water Resources Map" drawing, prepared by Doug Jacobsen and Chuck Easton, revised June 26, 2020 (enclosure 2).

This verification letter does not constitute a determination of jurisdiction (JD). A JD is not required to process an application for a Department of the Army permit. If you do not require a JD for the site, your permit application may be processed sooner.




