

My experience has shown me that collaboration yields better decisions only as each member of a team feels comfortable and confident sharing her/his perspective.

You have been given the codified responsibility to adopt a yearly budget for the Wasatch County School District. If given the opportunity to be your Business Administrator, I will work diligently with each of you as well as the Superintendent and district administrators in a collaborative way to help you accomplish your most critical responsibility.

#### **Communication is Kev**

Nothing is more important to a healthy school district than effective and timely communication among school board members, district leadership, school administrators, and members of each school's faculty and staff. I know the Wasatch educators. I have worked among them for 25 years and am able to communicate both critically and constructively with administrators and faculty members.

Communication is also essential from a school district to the members of the community it serves. Each of you represent a section of our community and are often asked to communicate the district vision and answer questions about decisions made by district leadership. You should feel comfortable and confident in seeking input/answers to these questions from your Business Administrator and other district staff. If selected to serve in this capacity, I will be able to communicate these complex issues in a manner than is understandable to each of your constituents. I believe in being transparent with our community. Decisions that cannot be justified to community constituents should be reconsidered.

I love Wasatch County School District, and I'm proud to have been an integral part of the work of transforming this district from a small, rural district to one looked to by state and national educators as a leader in many important 21st. Century initiatives. I've had the opportunity to lead some of these initiatives (Wasatch CAPS), and I've played supporting role in others (Professional Learning Communities). But whether leading or supporting I've learned countless lessons from the invaluable experience of working shoulder to shoulder with the exceptional school board members and professional educators. These experiences have transformed me from an eager counseling intern at Wasatch High School to a seasoned district leader who is ready to apply the lessons I've learned to a new role as Business Administrator.


